The undersigned is interested in seeking the information regarding the Advertisement for the appointment to the post of Director in CPPRI under the above mentioned act.

SUBJECT MATTER OF THE RTI APPLICATION

This is with reference to the Advertisement for the post of Director in CPPRI (<https://cppri.res.in/sites/default/files/Advertisement%20for%20post%20of%20Director.pdf>).

This advertisement with respect to experience and desirable qualification states that
(1) Experience: 15 years relevant experience out of which five years experience in a senior position in the pay scale of Rs. 37,400- 67,000 plus GP 8900 (pre-revised) (Revised PML-13A) or analogous post as Departmental head in Production or Engineering or Research or Project Planning in Pulp & Paper Mill or in a reputed Research Institute in Pulp & Paper Technology in India or abroad.

(2) Desirable Qualifications: Experience as Chief of similar research organization in an industrial complex or reputed research establishment in pulp and paper.

However, the meaning or definition of terms such as analogous post, reputed research institute/reputed research establishment, and similar research organization are not clearly defined in the advertisement. In various advertisement for the key posts like this, these terms are clearly defined. For example: In an advertisement for lateral recruitment of joint secretary and director level posts, Union Public Service Commission (ADVERTISEMENT NO. 51/2021) has defined the comparable equivalent level as follows:

a) The candidate applying for Joint Secretary level post (Pay Level-14 in the Pay Matrix as per 7th CPC) must have a minimum gross salary of Rs. 20 lakh per year during any of the financial year 2018-19 or 2019-20 as per Form-16/ITR (or payslip in the absence of Form-16/ITR).

b) The candidate applying for Director level post (Pay Level-13 in the Pay Matrix as per 7th CPC) must have a minimum gross salary of Rs. 15 lakh per year during any of the financial year 2018-19 or 2019-20 as per Form-16/ITR (or payslip in the absence of Form-16/ITR).
