

O R D E R

Pursuant to the directions of this Court dated 26 April 2019,
a Status Report has been filed on behalf of the Union of India by

the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Government of India. This Court had directed that:

“(a) All Ministries and Departments (including PSUs under the administrative control of the Ministries concerned; the Reserve Bank of India and all Nationalised Banks) need to complete the exercise of identifying posts suitable for all categories of disabilities covered by the Rights of persons with Disabilities Act, 2016 (RpwD Act, 2016) in terms of this Department’s O.M. No. 34-16/2018-DD.III dated 12/12/2018 within a period of three months, and
(b) The process of identification which is being carried out independently by the Expert Committee constituted under Section 33 by the Union of India shall continue and shall be completed expeditiously and preferably within a period of six months.”

Though the period of three months granted to individual ministries, departments and PSUs has come to an end, Annexure R-2 to the Status Report says that some of the departments have still to complete the process.

We direct that the departments which need to carry out the process of identification shall positively complete the process no later than by 10 September 2019. In addition to the above, it has been stated that the Union of India is on track to complete the process under the auspices of the Expert Committee constituted under Section 33 of the Rights of Persons with Disabilities Act, 2016¹ by the end of October 2019. We record the assurance.

We direct that immediately on being identified, the posts shall be notified for information and uploaded on the websites of the concerned Ministries or, as the case may be, departments. In

respect of the posts which have already been notified, the process to upload be completed within four weeks from the date of this order.

Mr. Anand Grover, learned Senior Counsel appearing on behalf of the petitioner states that the petitioner had applied for selection in three different posts, but was not informed as to whether these posts fall within the purview of Sections 33 and 34 of the Act of 2016.

Having regard to the submission, we permit the petitioner to address communications to the departments with a copy of this order. The departments shall furnish to the petitioner information on whether the posts which have been applied for fall within the purview of the provisions made under Sections 33 and 34.
