Appellant and Respondents both appeared before the FAA personally and made the submissions at length on 2.5.17. Dr. B.P.Thapliyal, Public Information Officer, Central Pulp & Paper Research Institute, Saharanpur presented the case.

**Brief relevant facts:**

Shri J.S.Bist, Assistant, CPPRI, Saharanpur, the appellant vide his application dated 20.2.17 sought RTI information from the respondent. RTI Application dated 20.2.17 was sent to Administrative Office, CPPRI, Saharanpur by the Public Information Officer vide letter dated 20.2.17 for providing necessary information/certified copies of documents as sought by the applicant. The information received from the Administrative Office, CPPRI was made available to Shri Shri J.S.Bist vide AO letter No.CPPRI/F&A/TA/ dated 20.3.17.

Dissatisfying with the reply of Public Information Officer, Shri J.S.Bist submitted an appeal to the First Appellate Authority, CPPRI vide his application dated 6.4.17.

**Investigation & Decision:**

It is mentioned that Admn. Officer, vide his response letter No.CPPRI/F&A/TA/ dated 20.3.17, <sup>has</sup> not provided the required information to the appellant by stating as, "Point No.1 to 3-are not related to Finance & Accounts Division, Point No.4- Nil".
