
Number of representations were received from the Jr. Assistants regarding implement the OM No. G.I. M.F., U.O., No.10/1/2009-IC dated 14.12.2009 to fix their salary as per point No.(c) of the above Office Memorandum. The individuals have also requested to fix their pay as on 1.4.2006 from the date of their promotion in grade pay Rs. 4600 and recover the arrear of 6th Central Pay Commission from January to March 2006 i.e. up to their date of promotion.

As per rule all the Jr. Assistants who were placed in the pay structure of Grade Pay 4600 and promoted between 1.1.2006 to 31.8.2008 have the option to fix their salary in term of CCS (RP) Rules, 2008. They can opt to have their pay fixed from the date of promotion with reference to the fitment table of the upgraded pay scale i.e. pre-revised scale of Rs. 7450-11500 in which case, they shall not be entitled to arrears of pay from 1.1.2006 till the date of option.

The Institute has already implemented the CCS (RP) Rules 2008 in the Institute and Assistants of the Institute have been granted the pay structure of Grade pay Rs. 4600/-. In view of the above it is proposed to fix the salary of Jr. Assistants who have promoted to the Grade pay Rs. 4600/- as per terms of the above Office Memorandum.
