1. Miss. Himani Pandey was posted as P.O. from 22.06.2012 upto 19.10.2013 in Allahabad Bank, Bhuteshwar Road Branch.
2. The amount of House Rent Allowance Drawn by her during her tenure at Allahabad Bank, Bhuteshwar Road Branch was Rs 942.50/- Per Month for the period from July 2012 upto August 2013 and Rs 981.50 for the period from September 2013 upto October 2013 .

However, if you are not satisfied with our decision, you may appeal against our decision within 30 days, before the Appellate Authority, Head office, Kolkata as per provision of the said Act.
