Brief relevant facts:

A letter dated 20.5.16 has been received from Shri Amarjeet Singh addressed to the Appellate Authority, CPPRI, Saharanpur regarding some RTI reply made by PIO in the matter of Shri Kawaljeet Singh. Shri Amarjeet Singh did not mention the details about the RTI. In absence of the details, it is difficult to find out the case.

PIO looked into the matter in detail and find out that a RTI was submitted by Shri Amarjeet Singh on 18.3.15 in the Institue. The said RTI was duly replied by the PIO on 22.4.15. The RTI was related to 'third party' information for which 'third party' has objected to disclose the information.

It is also mentioned that under Section-19 (1) of RTI Act.2005 an appellant may appeal to First Appellate Authority within thirty days on receipt of decisions of PIO. In this case the appeal has been made after 12 months, on expiry of prescribed period of thirty days. As per rule, the appeal is not tenable but taking sympathetic view the appeal is being considered.

DECISION:

Going through the RTI, it is found that Shri Amarjeet Singh had asked the information/documents of all types of Accounts, FDs, Safes and Lockers in various banks which was available with Dr. Kawaljeet Singh, Scientist E-I, CPPRI. This is 'third party' information under Section-11 of RTI Act.-2005. In the case 'third party' had objected to disclose the information. Undersigned agree with the decisions of PIO which was communicated to Shri Amarjeet Singh vide letter dated 22.4.15. A copy of the same may again be sent to Shri Amarjeet Singh along with the decision.

With this remarks the complaint is disposed of.


