1 & 2	Recruitment Rules for Scientific, Technical & Support Staff Services (Rules) are available on the Institute website www.cppri.res.in which may be seen on the website. Regarding recruitment of temporary project staff, it is informed that Recruitment is done as per the requirement of the Project based on the guidelines issued by Department of Science & Technology. The copy of the advertisement published during the year 1990 to 1999, being older more than 25 years are not available. However, it is informed that all the advertisement were posted on the Institute website regularly.
3.	M/s News Field Agency, M/s Xs communications and M/s Jain Advertising Agency were engaged for publication of recruitment advertisements. The exact amount paid to agencies is not traceable right now finance section of the Institute.
4.	Under section 8(j) of the provision of the RTI Act, 2005, information which has no relationship to any public activity or interest, or which could cause unwarranted invasion of the privacy of the individual is exempt from disclosure. Hence the information sought cannot be disclosed under the said provision of the RTI Act.
5.	Reservation in recruitment of posts is provided in the Institute as per the guidelines and instructions issued by Department of Personnel & Training (DOPT), Government of India from time to time. Reservation roster is maintained in the Institute.
