<p>Information Sought : 1. The Central Pulp and Paper Research Institute is an autonomous body under the Ministry of Commerce and Industry. Does CPPRI give age relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Castes in the temporary posts for appointments in the project? If no then why?</p> <p>2. Does the SC, ST and OBC candidates ever get age relaxation on the appointments made on temporary posts after 2005? Pls provide information in this context.</p> <p>3. The Central Pulp and Paper Research Institute follows the rules of DST in the appointment of temporary posts in the project. In the year 2016, the institute increased the honorarium of the project staff only after obtaining the approval of the RAC (Research Advisory Committee) to implement the DST (Department of Science and Technology) rules. Therefore, in the advertisement of new appointments issued by the Central Pulp and Paper Research Institute, the age and honorarium have been fixed according to the new rules of DST. Therefore, Central Pulp and Paper Research Institute please tell whether this time the approval of (Research Advisory Committee) was required to follow/implement the new rules of DST or not.</p> <p>4. I was selected on the post of Junior Research Fellow in Central Pulp and Paper Research Institute in 2009 and at that time I was already getting age relaxation due to being a Scheduled Caste. I had also</p>	

submitted my caste proof. In 2016 also in my offer letter it was written to submit schedule caste certificate. And I had also submitted. Therefore, according to the new advertisement, now the institute is not giving age relaxation to Scheduled Castes. Therefore, my question is whether the institute had issued any circular, according to which they have refused to give age relaxation to Scheduled Castes.

5. I would like to inform you that DST has not mentioned anything to give age relaxation to Scheduled Caste and not to give relaxation to Scheduled Caste. Because the institute has been giving age relaxation before also, so why is it not giving now. If you think that I am giving you any wrong information, then you should verify your record, in that the age relaxation has been given to Scheduled Castes.

6. I request the institute to provide a copy of whatever advertisement you have published for project appointments after 2008 to the applicant.

7. It is another request that whatever you will provide me, please cross verify from your records, because, I have the advertisement in which age relaxation has been given to me as a Scheduled Castes candidates for project posts.

8. The information received by you will be used to challenge the rights at different forums of the Government of India constitute for rights of SC & ST community. Therefore, it is requested that Director may please instruct the institute to provide information carefully.
