**Notice for Expression of Interest**

The Central Pulp & Paper Research Institute (CPPRI), Saharanpur, an autonomous body under the administrative control of the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce & Industry, Government of India, invites Expression of Interest (EOI) from eligible and experienced firms for participation in a technical consultation meeting.

CPPRI intends to set up a Storage-cum-Demonstration Shed within its premises for installation of two pilot demonstration units, namely Membrane Filtration Technology Unit and Black Liquor Heat Treatment Technology Unit.

The indicative scope of work includes, but is not limited to:

- Construction of a covered, protective shed of minimum size 30 ft × 50 ft
- Provision of all associated civil, electrical, structural, and utility works
- Supply and installation of all materials required for complete execution of the shed

This EOI is being issued to invite competent and experienced firms to participate in a technical consultation meeting and finalize the technical specifications and scope to be incorporated in the tender/bid document.

**Interested firms are required to satisfy themselves that they meet the following eligibility criteria prior to attend the technical consultation meeting:**

- The firm should be duly recognised by any Central/State Government organization/PSU department for execution of civil, electrical, mechanical, or related works.
- The firm should have at least 03 (three) years of experience in similar works in Central Government / State Government / PSU organizations.
- The firm should not have been blacklisted, de-registered, or debarred by any Government Department, PSU, or Private Organization during the last three financial years or currently.


